1. Common regulations

The Memorandum of Cooperation (referred to as "the Memorandum") defines relations and directions between youth and other non-governmental organizations. The institutions and organizations that were called in the Memorandum are referred to as Parties.


The Parties shall conclude this Memorandum based on the fact that only active cooperation of civil society institutions focused on conscious socialization of the younger generations gives an opportunity to ensure the formation of young people's system and these values and rules of the modern democratic world. This wide involvement of adult participants creates the unique opportunities for civic education and the formation of social skills in a democratic society at the same time in the teaching and educational process in non-governmental organizations.

This Memorandum does not contradict the goals that its parties set for themselves. Only specifies some of them and defines the principles and directions of cooperation between its Parties. Any activity under this Memorandum is governed by current legislation. The Parties shall interact on the principles of equality, frankness and charity.

2. Principles of cooperation by the Parties

To implement the Memorandum, the Parties agree to adhere to the following principles of cooperation:

- ✓ systematic communication between local authority staff and self-governing bodies of territorial communities, education authorities, educational institutions, and non-governmental organizations, which aim an active participation,
- ✓ coordination of joint activities between non-governmental organizations, authorities and local authority staff through a permanent consultative body with



clearly defined powers, consisting of special representatives from each Party concerned;

- ✓ implementing civil society's priority objectives.

3. Areas of cooperation of the Parties

- ✓ the parties agreed to cooperate in such sphere and directions:
- ✓ to cooperate during such events (seminars, trainings, lectures, conferences, etc.) aimed at meeting the standards of behavior of a conscious citizen, development of training and communication skills, ability to interact and respond to the challenges of public life;
- ✓ development and implementation of educational and information programmes and courses as well as projects aimed at civic education and national education in order to form the public opinion
- ✓ consultation with the purpose of development the coordinated positions on the decision of the most acute and actual problems in the sphere of training and education, exchange of experience in the organization of educational affairs;
- ✓ promotion of awareness through the role of non-governmental organizations in society. To raise the level of legal awareness in society concerning public position and organization. Popularization of the provisions about the Laws of Ukraine "About non-governmental organizations " and "About voluntary activities", other regulations governing public activities in Ukraine;
- ✓ any other forms of cooperation agreed upon by the Parties.

4. Mutual obligations

Non-governmental organizations will sign this document annually.

The members authorized by the organizations-signatories to the Memorandum will perform faithfully the duties defined in the Regulation.

Promotion of involvement of non-governmental organizations in trainings and other activities aimed at increasing positive image of the country. The organizations conducting these activities shall guarantee fair selection and safety of the participants.

5. Additional aspects of cooperation

The Parties shall interact with each other on the implementation of paragraphs according to this Memorandum through authorized representatives delegated by the Parties for participating in cooperation and friendship. The Parties agree that this Memorandum is flexible for signing by third parties with the consent of all its signatories.

The Parties agree that, unless otherwise agreed, each of them shall bear its own expenses for the tasks provided for in this Memorandum.

6. Concluding regulations

The Parties shall treat this Memorandum as a declaration of intent and shall not give rise to legal or financial consequences or obligations for any of them.



Each Party shall have the right to cooperate with a third party on any matters such as those set forth in this Memorandum. Nothing in this Agreement shall prevent either Party from entering into other agreements with other person.

All disputes concerning the interpretation and application of the regulation of this Agreement will be settled through consultation between the Parties.

All amendments and additions to this Memorandum shall be executed in written form and by agreement of the Parties.

This Memorandum shall enter into force from the date of its signing and shall remain in force until December 31, 2025.

Termination of the Memorandum shall enter into force three months after receipt of a notice by the respective Party. Thereafter, the Memorandum shall cease to be in force, except for the settlement of claims arising before the day on which the Memorandum is no longer in force, and any ongoing activities for the implementation of specific projects under the present Memorandum.

The text of the Memorandum shall be executed in 2 (two) copies in the Ukrainian/English languages, 1 (one) copy for each of the Parties, both texts being equally valid.
